



### Sexual Violence and Abuse Strategy Core and Enhanced Offer

The table below describes the current offer in relation to the strategic aims of the sexual violence and abuse strategy. Our aim is that survivors will be able to access services in a way that meets their needs and that services strive to provide services in an accessible way.

Services described as ‘core offer’ are core funded. Those described as enhanced are those services or projects that are currently funded through grant/short-term funding, are being piloted or are a priority if additional funding is identified. These services are at risk if additional funding is not secured.

This offer does not include the full range of services and processes addressing child sexual abuse and child sexual exploitation, which are covered in other policies.
